

RAGALTA PRIVACY POLICY

This Privacy Policy describes our policies on the collection, use, and disclosure of your information in connection with your use of our websites at www.ragalta.com and www.ragaltausa.com (collectively "Service"). The terms "we", "us", and "RAGALTA" refer to Kasulik II LLC DBA Ragalta USA, a Florida corporation (hereinafter "Ragalta").

IF YOU DO NOT AGREE TO THIS PRIVACY POLICY YOU MAY NOT ACCESS OR OTHERWISE USE THE SERVICE.

Personal Information We Collect: You do not need to provide us with any information in order to use the Service. However, in order to obtain support or to submit comments, and participate in discussion forums through third-party social media sites, you may be asked to provide, or you may choose to upload, certain personally identifiable information about yourself ("Personal Information"). Personal Information may include your first name, last name, street address, email address and telephone number. Personal Information is only collected when you voluntarily provide such information. It will always be your choice whether to provide Ragalta with your Personal Information, and when you do so, you are giving us permission to use the information to provide you with the requested services.

Non-Personal Information We Collect: We may also collect non-personally identifiable information, such as IP address, pages viewed, browser type, logon times, clickstream data and other data which does not personally identify you ("Non-Personal Information"). This type of Non-Personal Information may be automatically collected from you without any further notice when you use the Service. We may also create Non-Personal Information by combining your Personal Information with that of other users and present it in a manner that does not personally identify you (i.e., listing the number of users who are between the ages of 25-35 years old).

Personal Information Usage: Unless disclosed otherwise at the time of collection or in this Privacy Policy, we do not share any Personal Information you submit through the Service with any unaffiliated third party, unless it is necessary to respond to your requests, provide the service you have requested, or to comply with applicable law. We may share your Personal Information with our contractors and trusted third parties that we feel may offer you valuable information and/or services that appeal to our users.

We will use and disclose your information only as follows: (1) to confirm and fulfill your Service requests; (2) to follow up to make sure such requests are fulfilled; (3) if, in the course of using our Service, you opt to receive occasional emails from us notifying you of special offers, we will use such information to notify you of such offers; (4) if, in the course of using our Service, you opt to receive occasional emails from third parties to whom we provide your information, we will disclose such information to such third parties; (5) to protect the rights and safety of us, our shareholders, members, officers, employees and customers; (6) at our option, to notify you of any changes to this Privacy Policy or our other terms and conditions of this website (you are bound by the terms of

any changes we post to our website whether or not we notify you by email) and (7) as otherwise required by law. We disclose your information to third parties only as reasonably required to fulfill your Service requests, to protect the rights and safety of us, our shareholders, members, employees and customers (such as to legal representatives and law enforcement) as you expressly permit and as required by law (such as the result of a court subpoena). We may transfer your information in the event of the sale of substantially all of the assets of our business to a third-party or in the event of a merger, consolidation or acquisition. However, in such event, any acquirer will be subject to the provisions of our commitments to you.

We will never permanently sell your Personal Information to any third party not affiliated with Ragalta without your consent except in connection with the sale or merger of Ragalta or the division responsible for such services.

You should be aware that Personal Information which you voluntarily include and transmit online may be viewed and used by others. We are unable to control such uses of your Personal Information, and by using the Service you assume the risk that the Personal Information provided by you may be viewed and used by third parties.

Please note that we reserve the right to access and/or disclose Personal Information and Non-Personal information we gather as required by courts or administrative agencies and to the extent required to permit us to investigate suspected fraud, harassment or other violations of any law, rule or regulation, the Service's Terms of Service, or the rights of third parties or to investigate any suspected conduct which we deem improper.

Non-Personal Information Usage: We may use and disclose Non-Personal Information for any number of reasons, including to improve and enhance your experience on the Service and for our research activities. For example, we may share Non-Personal Information with unaffiliated third parties, such as business partners, in an aggregate, anonymous form, which means that the shared information will not contain nor be linked to any Personal Information.

Cookies and Similar Technologies: "Cookies" are pieces of information that may be placed on your computer by a website for the purpose of facilitating and enhancing your communication and interaction with that web site. Many websites use cookies for these purposes. We may use and place cookies (and clear gifs, web beacons and similar items that act like cookies) on your computer to customize your visit to the Service and for other purposes to make your visit more convenient or to enable us to enhance our Service. In addition, third party advertisers that may appear on our Service may also place cookies on your computer and use similar anonymous tracking devices. You may stop or restrict the placement of cookies on your computer or flush them from your browser by adjusting your web browser preferences, in which case you may still use our Service, but it may interfere with some of its functionality. We do not use cookies to automatically retrieve Personal Information from your computer without your knowledge.

Security Practices: The security of your Personal Information is very important to us. We have put in place reasonable physical, electronic, and managerial procedures to safeguard the information we collect. However, due to the inherent open nature of the Internet, we cannot guarantee that communications between you and us or information stored on the Service or our servers, will be completely free from unauthorized access by third parties such as hackers, and your use of the Service demonstrates your assumption of this risk.

We are not responsible for any breach of security caused by third parties or for any actions of any third parties that receive the information. We also may link to other websites or we may allow to be displayed on the Service advertisements of third parties. We are not responsible for such third party's privacy policies or how they treat information about their users.

No Users Under Age 18: We have no intention of collecting Personal Information from people under the age of 18. When we become aware that Personal Information from a person under 18 has been collected, we will use all reasonable efforts to delete such information from our database. Changes to Privacy Policy: We reserve the right, at our discretion, to change, modify, add, or remove portions from this policy at any time. However, if at any time in the future we plan to use Personal Information in a way that differs from this policy, we will post such changes here and provide you the opportunity to opt-out of such differing uses. Any changes in our Privacy Policy posted to this website will become effective as of the date of posting with respect to information we then collect in the future, but will not be changed with respect to information that we have then already collected. It is and will be your responsibility to review our Privacy Policy from time to time to make sure you are aware of any changes. Your continued use of the Service following the posting of any changes to this policy means you accept such changes.

Opt-Out Process: We give you the option to remove your Personal Information from our list of active users completely.
